STIPULATED ORDER PARTIALLY MODIFYING THE ORDER OF JULY 30, 1998  
CONCERNING REIMBURSEMENT PROCEDURES

WHEREAS, the parties agree to the following modification to this Court's "Order Partially Modifying the Reimbursement Procedures of the Amended Remedial Order of May 6, 1997, and the Reimbursement Procedures Order of September 15, 1997," which was entered on July 30, 1998 (hereafter "Order of July 30, 1998"),

IT IS, ORDERED, ADJUDGED AND DECREED:

Paragraph 5 of the Order of July 30, 1998, is replaced with the following:

5. Beginning no later than October 1, 1998, and at least annually thereafter, Defendants shall inform providers of the procedures set forth in the Order of September 15, 1997. Defendants shall inform providers of the deadline in paragraph 2 of the Order of July 30, 1998, within thirty (30) days of that date being determined in accordance with the procedures set forth in paragraph 2. The deadline set in accordance with paragraph 2 of

the Order of July 30, 1998, shall be stated in each subsequent annual notice to providers.
