CONSENT ORDER MAKING A TECHNICAL AMENDMENT TO A
PROVISION IN THE JANUARY 25, 1999
"ORDER MODIFYING THE AMENDED REMEDIAL ORDER OF MAY 6, 1997
AND VACATING THE ORDER OF MARCH 27, 1997"

On January 25, 1999, the Court entered an Order Modifying the Amended Remedial Order of May 6, 1997 and Vacating the Order of March 27, 1997 ("Settlement Order"). Since that date, the parties have agreed to a technical amendment to paragraph 51 of the Settlement Order concerning the offer of scheduling and transportation assistance prior to the due date for EPSDT appointments.

Therefore, the parties agree to the following technical amendment. All paragraphs of the Settlement Order not specifically amended herein shall remain in full force and effect.

ADJUDGED AND DECREED AS FOLLOWS:


The following technical amendment relates to Section V of the Settlement Order:

1. Paragraph 51 is replaced by the following revised paragraph 51:

51. Beginning no later than the date of entry of this Order, Defendants shall offer scheduling and transportation assistance prior to the due date of each eligible child's periodic screening, laboratory tests and immunizations as required by the HCFA State Medicaid Manual, Section 5150. The offer of scheduling and transportation assistance may be made in conjunction with another communication prior to the due date of each eligible child's periodic screening, laboratory tests and immunizations.
